New Disclosure service for Peterborough Diocese

You will be aware from Andrew Roberts E mail of 6th November 2013 (sent by Sharon Welbourne) that our Criminal Records Disclosure Service is now accessed on line and managed by the Churches Child Protection Advice Service (CCPAS). May I encourage you as a Parish to sign up to this service, its much quicker in processing Criminal Record checks (now DBS checks) than the previous paper based system. **URGENT - CCPAS Disclosure and Barring Service
ACTION REQUIRED!**

The Diocese of Peterborough has partnered with CCPAS (Churches Child Protection Advisory Service) to provide its DBS (formerly CRB) Disclosure service and each parish is therefore asked to register in order to continue applying for disclosures. Once you have registered the service will be available to you. The Diocese of Peterborough will continue to operate as a Registered Body for disclosure and barring purposes for a transitional period.

About CCPAS

CCPAS was established in 1977 and provides an unrivalled professional safeguarding advisory service. The benefits to the parishes include:

- Access to the online e-bulk application system
- A much faster processing service via dedicated processing staff – many checks take just a few days to process from beginning to end

Action Required.

The Diocese of Peterborough / CCPAS Disclosure Service Booklet contains a Registration Form which should be completed and sent to The Diocesan Offices, The Palace, Minister Precincts, Peterborough. PE1 1YB. On this form you will need to provide the details of a Lead Recruiter. This will usually be but does not need to be the same person as the Parish Safeguarding Officer, but they will need access to a computer to process the online checks. Once you have been registered, your Account Manager at CCPAS will send you an email with full details of how to access the system.
