Young Carers: Who are They and Why do They Need Support? - Action for Children

A young carer is someone 18 years old or under who helps look after a relative with a disability, illness, mental health condition, or drug or

alcohol problem. This could be a parent or a sibling. Some children begin giving care from a very young age, and others become carers overnight. Caring for someone can be very isolating, worrying, and stressful. For young carers, this can negatively impact their experience in education. Over a quarter of young carers aged 11-15 regularly miss school. This can have a lasting effect on their life chances. Action for Children have written an excellent article on this vital issue.
