# Fourth Domestic Homicide Report - Vulnerability Knowledge and Practice Programme

The National Policing Vulnerability Knowledge and Practice Programme (VKPP), published its fourth annual report in March 2025. The report uses data deriving from the Domestic Homicide Project. These data sets came from across England and Wales. All deaths categorised as domestic abuse have been collated and examined in this manner.

The resulting informational matrix, has allowed the creation of an excellent picture of risk indicators and victim/perpetrator demography. Due to the VKPP's unique access to data, death information from this report is more detailed than that available from any non-government aligned source.

The report is well worth a look, and is filled with information which can aid us to respond to domestic abuse, understand domestic homicide and help us better understand victim responses. If interested in this report, please follow the link below:

# My wife's doing a what! How you can help children with leukodystrophies

My lovely wife, Kate, is the dare-devil in our family! She's the risk taker. She thinks nothing of swimming in very cold water. Kate's latest exciting plan is to do a wing walk atop a biplane above the fields of Essex. (I'm not sure I'm even going to be able to watch!)

Kate, and her business partner, Bryony, who together run Harbour Counselling, are flying high on Sunday 25th May 2025 to support an amazing charity, Alex, The Leukodystrophy Charity who provide valuable support to families affected with leukodystrophies.

Three years ago, Franklin was a quirky funny little boy enjoying his childhood with his family and friends. After concerns were raised with his eyesight, a brain scan showed that Franklin had a Neurological degenerative condition called Adrenleukodystrophy. Kate and Bryony have seen at first-hand the support that Franklin and his family have received from Alex, The Leukodystrophy Charity.

Leukodystrophies are rare genetic disorders that mainly affect the white matter of the central nervous system (ie the brain or spinal cord). They affect people of all ages and backgrounds, most notably children. Leukodystrophies are usually degenerative and in many cases, this sadly means a reduced or limited lifespan.

At the moment, Kate and Bryony are about half-way to their fundraising target of £1500. If you can find five minutes and £5 (or even more) to keep Kate and Bryony standing on the wing of a biplane, I know that more children and families like Franklin's will really appreciate the help that Alex, The Leukodystrophy Charity, can give them.

## Best Practices for Managing Images and Videos on School Websites

Earlier this month, the UK Safer Internet Centre published new guidelines to protect students and staff from digital media misuse. Educational institutions such as schools and collages must be kept secure in their virtual space, as much as their physical space. This is particularly important when discussing the practice of image/video management. In an educational setting, this sphere of safety management, typically looks to minimise data breaches and subsequent data distribution.

Media content online is an area of particular weakness. Publicly accessible platforms – school websites and social media accounts for

instance, must be carefully observed. Properly managing images not only safeguards students and staff but also reinforces their commitment to online safety and responsible digital engagement.

It is to this issue, that the UK Safer Internet Centre has crafted this guidance package, to shape strong defensive procedures against misuse of media. They have been produced in collaboration with the Professionals Online Safety Helpline, and UKSIC's own 'Early Warning Working Group'. ## 'Disguised Compliance: Learning from Case Reviews' - NSPCC

Last month, the NSPCC released their guide to learning lessons from case reviews. Using cases from 2022 – 2023, the document seeks to highlight frequently occurring practice issues. In particular when those issues revolve around disguising compliance. A term which has given this report its title.

Disguised compliance is frequently used to describe the behaviour of parents or carers who appear to co-operate with professionals in order to allay concerns and stop professional engagement. When this occurs attention can often be diverted towards attempting to address organisational, or personal issues of carers rather than the affected pupils. ### **Question of the Week**

How would you explain 'contextual safeguarding' in one sentence?

Child A lives in a quiet rural village. Child B lives in a busy urban area. How might the contextual safeguarding issues differ between the two children?

#### **Answer**

Contextual safeguarding recognises that young people can face risks outside their home, such as in schools, peer groups, or communities.

**Potential issues** (use these ideas as a discussion starter, these issues are certainly not only to be found in these stereotypes. Ask to what extent is this a true reflection)

For example, a 12-year boy living a rural area might be affected by online exploitation, isolation and limited access to support, exposure to harmful community norms or lack of anonymity. However, a 12-year-old boy living in a busy urban area might be more affected by peer group

violence, gang affiliation and exploitation, radicalisation or unsafe public spaces.
